

Interested in completing your Firefighting AAS degree at San Jacinto College?

Are you already a working firefighter or have you completed a fire academy? Then your next step could be a firefighting AAS degree. This handout serves as a basic description of the San Jacinto College Firefighting AAS degree and the process to successfully enroll in degree program.

Degree Information

The San Jacinto College Firefighting AAS degree consists of 60 credit hours. The first 24 hours are the fire academy courses. If you took the Firefighter Training Academy at San Jacinto College (or a similar program at another Texas college) you should be good to go without having to repeat these 24 hours. If you have your Texas Commission on Fire Protection (TCFP) Basic Fire Suppression certification you should be able to receive credit for these 24 hours though our credit by certification process (see below for details). The remaining 36 credit hours are made up of 18 hours of fire courses and 18 hours of general education courses. Credit By Certification

Do you already have additional TCFP certifications? If so, you may be able to receive course credit instead of repeating the course. The *Approved Electives* chart (above) provides a listing of courses and their matching TCFP certifications. A student must

complete three (3) non-developmental credit hours at SJC before a credit by examination application can be initiated. Students must earn at least 25% of the credit hours required for the degree through instruction at San Jacinto College and credit by certification hours do not count towards this requirement. The credit hours will count in hours used for financial aid decisions. A student must request to have the credit posted. Currently there is a \$20 fee per course. To receive credit, students should contact the Fire Protection program via email: fire.academy@sjcd.edu.

Transfer Credit

If you have taken college classes included another school that are included in our degree plan you should be sure to transfer the credits and have them evaluated. See steps #3 and #4 in the enrollment steps (below).

Tuition Exemption

Texas provides an exemption of all tuition and certain fees for courses in a firefighting degree plan for students who are full-time firefighters in a TCFP-regulated department, and certain other firefighters, who meet academic progress requirements. If you are unsure of your eligibility for the exemption, you should contact the Fire Protection program via email: fire.academy@sjcd.edu. If eligible for the exemption, any course listed in the Firefighting AAS degree plan (above) is covered. San Jacinto College did away with all fees a couple of years ago so the exemption covers the entire cost of covered courses. The only out-of-pocket course expense is likely the cost of the textbook(s). Before purchasing fire course textbooks students should check with their department as many department can provide the textbooks. To take advantage of the exemption students need to follow this process each semester:

- 1. Register for classes
- 2. Provide a current employment verification letter to any SJC business office. These letters are typically generated by your department's training division or Fire Chief's office. You must provide a letter each semester.
- 3. The business office will verify you meet the satisfactory academic progress and excessive course hours requirements. The business office will then contact the fire program to verify eligibility via the TCFP website and that the courses registered for are covered by the exemption.
- 4. If all requirements are met the exemption is applied.

5. If the business office tells you that you are ineligible due to excessive hours please contact the Fire Protection program via email: fire.academy@sjcd.edu.

Steps to follow in order to successfully enroll in the Firefighting AAS degree:

- 1. Submit an Application for Admission to San Jacinto College. Visit www.sanjac.edu and click on the Apply button.
- 2. A meningitis vaccination or booster is required if you are younger than 22. Visit www.sanjac.edu/meningitis for information.
- 3. Send official high school and/or college/university transcripts to our records management office. You can take classes at San Jacinto College for one (1) semester without submitting your official transcript, however, financial aid will not be awarded until all official transcripts are received. All foreign transcripts must be evaluated by an approved third-party evaluator. Details on how to submit transcripts can be found at https://www.sanjac.edu/transcripts
- 4. Please make an official request to have San Jacinto College evaluate your transfer college transcripts to determine what courses will transfer by scheduling a <u>virtual appointment via http://appointments.sjcd.edu/</u> or calling 281-998-6150. Transcripts must be received and on file with San Jac before students may submit an evaluation request.
- 5. Complete placement testing. Though you may be exempt, it is highly recommended.
- Claim SOS Login. SOS is San Jacinto College's "Secure Online System" for credit and continuing education students. When you apply to San Jac, an SOS account is created for you. Claim your student account at www.sanjac.edu/soslogin.
- 7. All first-time in college students are required to attend New Student Orientation prior to registration for classes at San Jacinto College. Visit

- <u>www.sanjac.edu/soslogin</u> to claim your student account and sign-up for orientation.
- 8. Meet with Advising. As part of our mission in ensuring student success, all students who are new to San Jacinto College will need to meet with an admissions advisor. Visit <u>appointments.sjcd.edu</u> to schedule a meeting.
- 9. If you are a veteran please consider visiting your campus veteran center or www.sanjac.edu/veterans to learn about veteran services.
- 10. If you are an international student please visit the South Campus to speak with an international advisor or visit www.sanjac.edu/international-students.
- 11. If you are a student who may need extra assistance to proceed in your college coursework please contact the Accessibility Services office at 281-998-6150, x1014, or visit www.sanjac.edu/accessibility to learn about services available to you.
- 12. If you are not eligible for the firefighter tuition exemption you may consider applying for financial aid: Complete the FAFSA at www.fafsa.ed.gov. Our FAFSA code is 003609. Contact the Financial Aid office, if needed. 281-998-6150.
- 13. Apply for Scholarships: Visit https://www.sanjac.edu/admissions-aid/scholarships-grants to research available grants and/or scholarships.
- 14. After all admission requirements have been met you may register for classes. Register for classes via SOS. **Current registration details are included later in this packet.**
- 15. Pay for your classes. See the current San Jacinto College schedule for the payment schedule and the current tuition amounts.
- 16. Get your student ID card. ID cards can be obtained from any campus Admissions office. *Available 24 hours after tuition payment*
- 17. Set up your San Jacinto College email account at https://www.sanjac.edu/email

18. Get your parking permit. Parking permits are available at any campus business office with a San Jac ID card and ID number (G#).
